

## Undocumented Student Verification and Residency Form

Students who are not US citizens, permanent residents, nor on a F1 Student Visa are entitled to in-state or in-district tuition if they graduated from a high school in Illinois or received a GED in Illinois, or are currently attending high school in Illinois. These rules are based on Illinois Public Act 93-0007. **Students only need to complete this form if they are undocumented and have a residency status as "Foreign or International" in LLCC's systems.** Students should contact LLCC to verify their residency status. Undocumented students who meet and verify the following criteria will be charged the in-state or in-district tuition rate.

	<i>Criteria</i>	<i>Documentation Needed</i>
High School Graduate	Student graduated from high school or received a GED in the state. OR Attended high school in the state for at least 3 years as of the date the individual graduated/received a GED.	Official high school transcript or GED documentation must be provided with this document.
Current High School Student	Student resides with their parent(s) or guardian while attending a high school in the state of Illinois.	Verification that student will file an application to become a permanent resident of the United States at the earliest opportunity by signing this form. No other documentation needed.
