#### **Admission Requirements (Admission and program requirements are subject to change):**

- ☐ HS transcript with proof of graduation or GED certificate on file in Admissions & Records Office
  - ☐ Complete an informational session given by the Surgical Technology director or complete the online information session located at <http://ww3.llcc.edu/surgical-technology>
  - ☐ ACT composite of 19 or higher OR SAT total score of 980 OR achieve an overall score of proficient on the TEAS test. (ACT/SAT/TEAS waived if student has Bachelor's degree or higher)
  - ☐ Demonstrate placement out of MAT 082
  - ☐ Demonstrate placement into EGL 101
  - ☐ Complete HLT 109 (Medical Terminology) with a grade of C or better before admission
  - ☐ GPA of 2.5 or better for all previous college courses
  - ☐ Official transcripts from **all colleges ever attended** evaluated by Admissions & Records Office. Students that neglect to do this, or delay doing this, may jeopardize their ability to apply to, be accepted to, or remain enrolled in a health professions program at LLCC.
  - ☐ Submit the Surgical Technology Application

**\*Students must be eligible to take BIO 175 or must have taken BIO 175 within the past 5 years with a "C" or better in order to enter program. See BIO 175 prerequisite requirements on backside of checklist.**

Students **do not** need to complete these courses prior to entering the program. It is encouraged that students enroll in these courses if they are on the admission list and are waiting to start the program in order to lighten their course load within the program. Once students begin the program, it is 5 semesters in length (Begin in June, graduate the following December).

**Surgical Technology classes:**

**SGT 101** (Introduction to Surgical Technology), **SGT 105** (Principles of Asepsis), **SGT 108** (Pharmacology for the Surgical Technologist), **SGT 112** (Principles and Practices of Surgical Technology), **SGT 200** (Surgical Procedures I), **SGT 201** (Clinical Internship I), **SGT 202** (Surgical Procedures II), **SGT 203** (Clinical Internship II), **SGT 204** (Surgical Procedures III), **SGT 205** (Clinical Internship III)

**\*REQUIRES ONE YEAR OF HIGH SCHOOL BIOLOGY WITH A GRADE OF “B” OR HIGHER WITHIN THE PAST 5 YEARS OR BIO 101 WITH A GRADE OF “C” OR HIGHER WITHIN THE PAST 5 YEARS OR A PASSING SCORE ON THE BIO 175 PREREQUISITE WAIVER EXAM WITHIN THE PAST 5 YEARS**

**\*ALL PREVIOUS SCIENCE COURSES MUST BE COMPLETED WITH A MINIMUM GRADE OF “C” WITHIN 5 YEARS OF APPLICATION DATE.**

Following acceptance to the program, students are required to have:

- A health assessment performed at the student’s expense
- Documentation of immunizations
- A criminal background check and drug screening performed at the student’s expense
- CPR certification for Health Care Providers (must be completed by end of second semester of the program)
- Influenza vaccines (completed in the fall of 1<sup>st</sup> and 2<sup>nd</sup> year)

**Residency Criteria:**

**Chapter 112, Section 103-17, of the Illinois Public Community College Act requires that whenever enrollment in a program must be restricted because of space limitations, a college must give preference to district residents. Consequently, admission to Health Career programs for students who live outside of LLCC District #526 vary per program based on space available and qualified applicant pools.**
