The following is a proposed change to Board Policy 4.14 – Grade Review

Any student who feels that a final grade has been unfairly or inappropriately assigned may request a grade review. Every effort should be made to resolve the issue informally before pursuing the formal grade review process. This procedure is not intended for reviewing the professional judgment of faculty regarding the assessment of the quality of work of their students and shall not abridge, circumvent, nor diminish academic freedom in any way. This policy does

not apply to administrative withdrawal grades that are given at the state and federal reporting deadlines.

Reviews are appropriately claimed, but not limited to, allegations such as the following:

- 1. Assignment of grades on the basis of factors or by methods not stipulated in the course syllabus;
- 2. errors in the calculation or recording of course grades;
- 3. inconsistency in the assignment of course grades; and
- 4. assignment of grades on the basis of factors unrelated to academic performance or quality of work in a course.

This change is being presented for a first reading tonight. No action is required at this meeting. With Board concurrence, we will return this policy to you for action at the regularly scheduled April 2023 meeting of the Board.

- B. President's Report

We are actively promoting the action the Board of Trustees took last month to freeze standard tuition for the coming academic year. We are also promoting the three, free programs offered this summer through grant funding. Those include:

- 3 for Free! where new college students can choose a free, three-credit class to take this summer. Also eligible are former LLCC students who did not complete a degree or certificate. Free books, supplies and tutoring will be provided. 3 for Free is limited to 150 students, with a percentage of spots reserved for low-income, first-generation and minority students.
- Summer Boost will help students gain confidence and get ready to start college. Participants can choose any combination of sessions to prepare them for college-level courses. Lunch, attendance incentives and mentoring are also included.
- Career Exploration allows adults with or without a high school diploma to learn about career fields and get ready to enter a workforce training program. Participants will attend workshops three days a week with guest speakers and tours of workforce training labs.

More information and registration for these programs are available on our website.

We welcomed several elected officials over the past week. Last Wednesday, Trustees Gordon Gates, Vicki Davis and Jeff Fulgenzi were on hand as Governor J.B. Pritzker held a press conference in the Kreher Agriculture Center on funding for higher education and a proposed increase in MAP grants. LLCC Ag Student Keziah Gragg spoke on how the MAP grant has helped fund her education. Other speakers included Lieutenant Governor Juliana Stratton, State Senator Doris Turner, and State Representatives Mike Coffey and Katie Stuart.

On Monday, State Senator Mattie Hunter from Chicago spoke to Adult Education classes and later toured the Workforce Careers Center. She made several very positive comments on our facilities, the range of offerings, and about our faculty and students as she walked around meeting a number of them.

For the first time, Workforce Institute students participated in the Skills USA competition. SkillsUSA is a non-profit national education association. 11 students have advanced to the state competition in Peoria next month. They are competing in 6 programs: Culinary Arts, Carpentry, Auto Tech, Electrical Wiring, HVAC, and welding). The state competition will be at the Peoria Civic Center April 27-29. If successful there are national competitions.

Last week, members of our Ag Club traveled to Iowa for the National P.A.S. (Postsecondary Agricultural Student) Conference. The Soils Specialist Team was named 2023 National P.A.S. Champions. LLCC will serve as the host site for the 2024 National P.A.S. Conference

The Livestock Judging Team recently wrapped up its season at the Houston Livestock Show. The team placed 11th overall with several additional team and individual placings. The team also finished 9th overall at San Antonio, with a 1st place in sheep judging. Eight members of the team are being recruited to join judging teams at universities including Colorado State. Purdue. Iowa State and Texas A and M.

Our Occupational Therapy Assistant (OTA) program is partnering with Boys & Girls Clubs of Central Illinois on the "Healthy Minds, Hearts & Hands" program this month and next. Funded by an IDI (Innovation in Diversity and Inclusion) grant, Mighty Minds, Heart and Hands is a service-based learning project for at-risk youth in which OTA students and staff work with the Boys and Girls Club on an afterschool program at DuBois Elementary each Monday in March and April. The project seeks to also increase community awareness of and diversity of students in the OTA program.

Some recent changes in the Advancement office include, moving Brenda Elliott, Director, Work-Based Learning, Marina Wirsing and Cathy Huffman, Career Coaches under Josh Collins, Assistant Vice President of Business Relations. We are implementing two pieces of software to help manage the many contacts we have with businesses. Salesforce will be extremely useful to that staff, as well as our faculty and deans. The second is Handshake. Our old job board was not adequate, and we found that many employers have already been using this to find and recruit employees. The employer launch has been very successful. We are now connected to 178 employers. We anticipate nearly 200 by the end of the week and will keep working for more. The student launch is set for April 13. Our aspirational goal is to have every student at LLCC posted on this site to better enable them and employers to find good matches. Ultimately, we are also hoping to connect alumni into our work around these projects and be a stronger resource for them.

The spring 2023 edition of FORWARD magazine has arrived in mailboxes throughout the LLCC district and is now available online.

Finally, Dr. Warren asked the board if they wanted to participate in the ICCTA Lobby Day. With the new legislative maps, we now have 15 state legislators in the LLCC district. Many of which we have never worked with. The board discussed different ways to meet and introduce LLLCC to the legislators.
