1. Revision to Board Policy 5.47 – Volunteer Emergency Worker Higher Education Protection

In response to recent amendments to the Public Higher Education Act that include provisions for military service members, the following revisions are being made to Board Policy 5.47 – Volunteer Emergency Worker and Military Service Member Higher Education Protection.

#### **Policy Statement:**

In accordance with 110 ILCS 122/1, Lincoln Land Community College shall reasonably accommodate any student who is

- 1. A volunteer emergency worker in regard to absence in class caused by the performance of their duties; and/or
- 2. A member of the National Guard of any state, the District of Columbia, a commonwealth, or a territory of the United States, or any reserve component of the Armed Forces of the United States, or any active-duty military member, in regard to classwork and assignments missed due to participation in a drill or other required military obligation.

Accommodations will be considered in regard to class attendance, the scheduling of examinations, and work requirements, provided that make-up examinations/assignments shall not create an unreasonable burden for the staff. Students must notify their instructor (or supervisor in the case of student employees) of any anticipated absence according to the procedures for this policy. Any student who believes he or she has been unreasonably denied this accommodation may seek redress as outlined in the procedure section.

Registration for spring classes began today. Prior to this, our Student Success office recently hosted events to answer questions and help students schedule advising appointments to get them ready to register.

The fall edition of FORWARD magazine will be going out soon. It covers the latest happenings at the college, including articles about the new construction lab, occupational therapy assistant program, professional development opportunities, RISE technology, student wellbeing services, as well as our Phi Theta Kappa and Honors programs. It also featured spotlights on Heidi Wilson, nursing student; Patrick Pianezza, alum who has written the feature film "Code 3"; Richard Hayes, student success advisor; and Dr. Matt Schownir, professor of history.

Public Relations & Marketing also recently won a bronze Medallion award at the National Council for Marketing & Public Relations' District Conference. The award recognizes the design work on a sticker featuring Abraham Lincoln in sunglasses and the college's logo. It has been a very popular giveaway at events!

Campus Visit Day was held on Monday. We had more than 100 prospective students, and their guests take tours, speak with faculty, and staff, and learn about our programs and the next steps to becoming a student.

We had great student attendance at our Fall Internship and Job Fair, which was held Tuesday. It was a great opportunity for students to connect with approximately 20 organizations offering spring and summer internships, as well as part-time employment in a

variety of industries — including business, medical, banking, accounting and finance, law enforcement, the State of Illinois, and non-profits.

LLCC-Jacksonville is hosting a Workforce Institute Showcase today, offering helpful resources, insights, and support to help prospective students take the next step in their educational journeys. This spring, LLCC-Jacksonville will offer industrial technology training. The year-long certificate of completion merges classroom education and job shadowing. Students will be able to apply what they learn directly through on-site internships, thanks to partnerships with local companies.

We recently welcomed Shane Garrison of the Bricklayers and Allied Craftworkers Local 8 for a three-day visit with students in our construction technologies and Sangamon County MC3 pre-apprenticeship programs. He shared valuable insights and worked directly with students, teaching them hands-on skills in laying block and brick structures. It provided a real-world look at the craftsmanship and precision involved, while also highlighting career opportunities available through Local 8's apprenticeship program.

We held our annual outdoor Career Expo on September 25<sup>th</sup>. More than 1,300 students came to campus, took tours, and visited with 120 employers in the exhibit area, learning about careers in workforce, health care, agriculture and more.

The annual Carboard Boat Regatta was held on September 26<sup>th</sup>. A total of 15 teams competed. First place went to The Learning Center and their boat named "SL2: Judgement Day." It was a great day with a total of nine awards presented—including the President's Choice Award, which went to the boat "Good Grief, It Floats!" sponsored by the Office of Student Engagement and Wellbeing.

Other events held recently include:

The 21<sup>st</sup> annual Multicultural Fest on October 8<sup>th</sup>. It featured exhibits, entertainment, and food trucks. 168 passports were completed at the event.

Lit Fest was held October 6<sup>th</sup>-9<sup>th</sup> with activities including a banned books reading, student author reading, and adopt-a-book fundraiser.

The past month has included multiple Hispanic Heritage Month activities. Today we held the closing fiesta.

The Haunted Lab will be making a return this year on Octboer 24<sup>th</sup>, 5-8:30 p.m. in upper Sangamon Hall. Children can come in costumes and enjoy spooky science demonstrations and interactive stations with hands-on activities in biology, geology, geography and more.

Bistro Verde will be providing a full-service lunch experience Tuesdays through Thursdays starting October 28th (and that runs through December 4<sup>th</sup> — with the exception of the week of Thanksgiving).
